- Boat shed - Shelves purchased, to be installed next week
- Extrication equipment - The power unit engine has been repaired, again this time with load applied.
- Apparatus maintenance
 - We are going to start taking apparatus to Beck's Automotive on Boy Scout Rd for annual inspections and maintenance starting late spring. Tire chains must be removed prior to taking to Beck's.
